GENTEXT/1. SITUATION/A WINTER STORM WARNING HAS BEEN ISSUED ACROSS THE COUNTRY: Heavy snow expected. The snow may mix with or change to sleet Sunday evening. Total snow and sleet accumulations between 10 and 14 inches in portions of northeast New Jersey and southeast New York from 3 AM Sunday to 6 PM EST Monday. Roads will become snow covered and hazardous. Visibilities may drop below 1/4 mile due to falling and blowing snow. Persons should consider delaying travel from Sunday into Monday. If travel is absolutely necessary, drive with extreme caution. Make sure your car is winterized and in good working order. Consider taking a winter storm kit along with you, including such items as tire chains, booster cables, flashlight, shovel, blankets and extra clothing. Also take water, a first aid kit, and anything else that would help you survive in case you become stranded.
